NOTICE OF RACE

NB: The notation '[DP]' in a rule in the Notice of Race means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).
- 1.2 RRS Appendix C shall apply.
- 1.3 The Starling Class Rules shall apply.

2 ELIGIBILITY AND ENTRY

- 2.1 To be eligible to compete, each competitor must be under 19 years of age on 26 January 2021.

2.2 To be eligible to compete, each competitor shall be a financial member of a club in the Auckland Region as defined in the *Rules for the Starling Match Racing Championship* (see www.starling.org.nz).

2.3 The entry form is appended to this Notice of Race. Please email your completed form to paul.webber@wedgewoodwhite.com. Entry forms must be received by 5pm on 12 December 2020.

3 ENTRY FEE

Entrants shall pay an entry fee of \$40 by 12 December 2020. Please pay by direct deposit into the Glendowie Boating Club bank account: 03-0195-0234682-00. Please include "SMR AKL" and your surname in the reference fields.

4 EVENT SCHEDULE

4.1 The target programme is set out in the table below:

4.2 The organising authority may change the format, or terminate or eliminate any round when conditions or the remaining time scheduled do not permit the completion of the target programme.

4.3 Prize giving will follow the end of racing.

5 SAILING INSTRUCTIONS

Sailing Instructions will be emailed to competitors on 15 December 2019 and posted on the Glendowie Boating Club website (gbcyachting.org.nz).

6 VENUE

The regatta venue is the Glendowie Boating Club, Glendowie Rd, Auckland.

7 COURSE

The course will be windward/leeward with starboard roundings, finishing downwind.

8 RADIO COMMUNICATION

Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats. This restriction also applies to mobile telephones. [DP]

9 PRIZES

The winner and second placed sailor will be nominated to represent Auckland in the 2021 Starling Match Racing National Championship.

10 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
